1 Preamble

A Second Chance aim to <u>create a positive</u> <u>environment</u> for collaboration between migrants, business and the governments of the United States and Mexico,

And in so doing advance the specific objectives as set out under objectives.

It therefore combines and seeks solutions that are:-

- Humane;
- Economically empowering and
- Within a framework of the legalities of the United States, Mexico and the E.U.;
- Focused on economic growth for the U.S.
 & Mexico, E.U. and Arab countries.

In short to advance and promote a win win scenario.

And in so doing:-

Support and maintain economic growth for both the United States and Mexico.

2 Objectives

The <u>primary objectives</u> of A Second Chance are to:-

- Empower undocumented and or illegal migrants in the United States and Europe.
 And that is in the U.S. and E.U. at the launch of the Initiative.
- To be able to voluntary return to their countries of origin in a manner that will provide:-
- **1.** A humane: Promote and support a humane re-migration process that empower migrants:

2. Economic empowerment;-

To resettle in the countries of origin and Start the process of building their lives and their own countries.

- **3.** <u>Collaborations</u>:- It is a development process to bring migrants, business and governments together to:-
- 4. <u>Develop sustainable long-term solutions</u>.

3 Specific support

- 1) Promote the objectives to the governments of the US, Mexico, E.U. and businesses, specifically:-
- 2) To mobilize and unlock economic support and income opportunities for migrants (that voluntary re-migrate to their countries of origin) via:-
 - 2.1) Business
 - 2.2) The governments and
 - 2.3) The migrants themselves through collaboration actions that minimize "overheads" and unnecessary cost factors associated with forced deportation.
- 3) Assistance to migrants as the developments unfold and become available under the Initiative with guidance to help migrants and their families with regards to:-
- 3.1) The legal options they have.
 - 3.1.1) Please note the Initiative is not a legal service but
 - 3.1.2) It is being developed to assist migrants to minimize legal expenses,
 - 3.1.3) With the specific aim to redirect legal expenses to be applied to start to build their future and that of their families
- 3.2) Re-migration financial support;
- 3.3) Re-establishing support;
- 3.4) Economic support and
- 3.5) Their active economic empowerment, this takes place within the framework of our SD2000 development program..
- 4) And where possible assist migrants to retain the right to legally apply for re-entry into the USA & Europe if they whish to do so at a latter stage.
- 4.1) Furthermore to overcome specific illegal actions, without further tainting and aggravating illegalities incurred when they entered the United States or Europe illegally.
- 4.2) Notwithstanding the aforementioned the Initiative will engage role-players to promote and work towards a decriminalize forgiveness option for migrants relating to

the illegal entry in the United States and or Europe.

5) Specific aspects with regards to remigration from Europe to Syria and other Arabic affected countries are:-

5.1) Safe zones

- 5.1.1) It is recommended that the Initiative & role-players takes into account safe zones as proposed by the new United States President Donald Trump.
- 5.1.2) And that the unfolding in the European theater takes place parallel with the establishing of safe zones.

4 Who qualifies?

Migrants who:-

- Entered the United States and Europe undocumented as and up to the 25St April 2017.
- Who do not qualify in the true sense for political asylum?
- Who have not committed murder, aggravated assault and or organized criminal activities.
- 4) Who wish or would like to return to their countries of origin with the specific objective to:-
 - 4.1) Participate in economic growth Initiatives to advance and
 - 4.2) or rebuild their own lives & countries of origin.
- 5) Who commit to training programs as an when made available under the Initiative, aimed specifically at:-
 - 5.1) Supporting resettlement;
 - 5.2) Accelerated economic development and
 - 5.3) Specifically strengthening civic administration.

5 Acknowledgement of legal framework

It is a specific understanding:-

- That the promotion of this Initiative and actions, including undertakings to migrants under the Initiative and
- Actions by migrants are subject to complying and adhere to the laws of the United States

and or Mexico. (Including European Union and or individual States in the E.U. when applicable.)

6 Donations application and the use thereof in the Initiative & development process

The Initiative is funded through business and individual membership subscriptions and donations:-

This framework with regards to the application and utilization of donations, including funding through business membership subscriptions, will apply.

- Taking into account that this is a development Initiative.
- With the specific development objective of sourcing and developing economic opportunities for the resettlement of undocumented migrants that re-migrate to their countries of origin, as setout herein.
- 3) In short, it is an Initiative that is pioneering a new approach to undocumented migration who re-migrate & resettle in their countries of origin.
- The development takes place on a multilevel facet.
 - 4.1) Development costs therefore are a core element of costs incurred.
 - 4.2) Notwithstanding this the objective is to limit development costs within the following framework:-
 - 4.2.1) Recovery of the initial foundation development cost outstanding of establishing the Initiative amounting to \$2.7 million U.S. dollars.
 - 4.2.2) Furthermore development costs target levels are to be within a 15% framework.
 - 4.2.3) Implying that 85% to 88% will go directly to support of migrants.
 - 4.3) Under 4.2.3) administrative and implementation costs target levels are on a sliding scale between 10% and 5%.
- It is a specific undertaking that all funding will be reported on and subject to audit reports by Price Waterhouse Coopers.

7 Specific undertakings by migrants, businesses, members & participants

- Migrants registering as mentors, businesses
 offering opportunities, members and
 participants undertake that he, she or they
 will fully comply with the requirements set
 by the Federal government of the United
 States, and
- 1.1) Of individual states wherever he or she might find herself or himself at the time of registration, as well as the requirements of Mexico as and when applicable.
- 1.2) And or the European Union and their individual states.
- 2) That should circumstances hinder a migrant to comply with a particular legal aspect due to circumstances outside of their control that he or she will as participant (s) of the Initiative inform the authorities as such.
- 3) And will further report and register with the authority (ies) or system (s) when provided by both the United States, Mexican and or European Union governments when such a system (s) are enacted.
- 3.1) They will inform the Initiative of their compliance as above.
- 4) That he or she <u>will voluntary leave</u> the United States or E.U. as and when requested under the Initiative of the United States an or E.U.
- 5) Migrants who register also undertake to provide, a <u>cell phone</u> contact number (Or email address) as contact number that can be used by the Initiative to communicate through SMS messages with the migrants.
- 5.1) Should such cell phone for some reason become inaccessible, the migrants undertake to immediately inform the Initiative and provide an alternative cell phone number.
- 6) These items will apply mutatis mutandis with regards to undocumented migrants in the European Union.

8 Acknowledgement of sovereignty

- Notwithstanding the fact that the Initiative is based on a core value of collaboration and empowerment, all participants acknowledge and agree to the following:-
- 1.1) The United States, Mexico and or any of the European nations and European Union affected by undocumented migrants:-
- 1.2) Is and are independent states.
- 2) And migrants that want to re-migrate and all participants in the Initiative herewith knowledge the independent sovereignty of each state the right of each state to:-
- 2.1) Act in the interest of the individual state being such action:-
 - 2.1.1) Legal
 - 2.1.2) Commercial
 - 2.1.3) Cultural and
- 3) Furthermore recognise, mutaul respect and the promotion of the sovereignty of states as a basis of collaboration.

9 Confidentiality of information

- 1) It is a specific undertaking by the Initiative and any participant under the Initiative, that all migrants' personal information, will at all times be treated as confidential and will not be utilized for any other reason other than the objectives of the Initiative.
- 2) Furthermore will not be disclosed without the written consent of a migrant, with a clear understanding that this undertaking is subject to the legal requirements of the United States of America and or Mexico and or European Union.
- And that the Initiative will inform migrants should such confidentiality be violated through individual states or laws in participating countries;
- 3.1) Subject there to that the migrant maintains an active contact number for SMS

- purposes (Or email address) as setout in 7.5).
- 3.2) When migrants fails to provide a contact number (Or email address) the Initiative will be relieved from any or all liabilities resulting from such non disclosure when contact with migrants lapse.

10 Limited liability

- It is a specific understanding by individuals, migrants and or businesses that this Initiative is conducted in utmost good faith.
- And that all individuals registered and or donating funds:-
- 3) By so doing acknowledges the following:-
- 3.1.1) That they have downloaded the Initiative's Framework (This writing);
- 3.1.2) And that they accept the framework;
- 3.1.3) Further more that they acknowledge the development nature of the Initiative and
- 3.1.4) As individuals, donators, funders, businesses and, migrants (including family members of migrants), members being registered members or not registered,
- 3.1.5) Acknowledge that participation within the Initiative is on the basis of utmost good faith, and
- 3.1.6) That participation takes place at the risk of any participant, being it a business and or individual, migrant and or family member of migrants.
- 3.1.7) And that the Initiative due to the very nature cannot accept responsibility and or guarantee undertakings.
- 3.1.8) Participants further acknowledge that these undertakings specifically relate to and include although not exclusive to that of legal and liability implications enacted by individual governments and or states.
- 3.1.9) And that this waiver extends to material and financial damage and or loss of opportunity, physical and mental damages.
- 4) That no guarantees are provided by the Initiative as to the level of assistance other than the following undertaking:-
- 4.1) All funding will be subject to international audit standards.

- 4.2) The Initiative's directors will in good faith promote and endeavor to mobilize maximum support for voluntary participating re-migration members and or their families.
- 4.3) The Initiative will furthermore provide through the underlying web site clear report backs as to the application of funds.
- 4.4) The Initiative will seek to establish an independent oversight and advisory board that will include members of affected communities and the migrant communities including participating businesses.
- 4.5) Applicants for such participation by migrants will be assisted with an independent blog page on the web to promote the policies and canvas support.
- 4.6) Migrants will at appropriate times, as to be determined, be able to vote for individuals to re-present them.
