"A Second Chance";- **is a voluntary re-migration and back to back business growth Initiative** to support and assist:-

**1) Undocumented migrants** that have not committed serious crimes and who are currently in the USA and Europe; And who want to voluntary re-migrate to their countries of origin.

The Initiative focuses on economic options and business opportunities to assist re-migrating migrants to re-establish themselves in their countries of origin.



**2) At the same time, the business options for migrants, open new growth opportunities for;- U.S. and Mexican businesses to grow, expand their businesses and to generate new export growth.**

Providing an overall win win scenario for undocumented migrants, U.S. & Mexican businesses and the U.S., Mexico and E.U. as a whole.

***"Overall and above war and civil unrest, the reality is that economic factors are the core drivers that impact both business and undocumented migrants."***

The debate on deportation, sanctuary cities and a path to citizenship might provide a political road forward but it does not provide a long-term sustainable solution; as long as the income disparity between countries remain.

Voluntary remigration can deliver major benefits and savings. The current U.S. deportation costs ranges from \$ 5,000 upwards. At a 6.5% voluntary re-migration participation, deportation costs can be reduced well in excess of \$3.800 million US dollars up to \$ 8.000 million US dollars.

***Research shows that 32% undocumented migrants would prefer to return to their country of origin.***

Providing they have assistance and can then at a later stage reapply for entry. Therefore not having to face deportation and losing the right of entry.

***It is time to act;-*** On the 2<sup>nd</sup> of September 2015 the three year old Alan Kurdi's body was recovered face down in the sand, after he drowned in the Mediterranean. Now nearly two years later and we are still only talking, it is time to act.

***The Initiative's framework;-*** The Initiative is a business Initiative and is apolitical, subject to the laws of the U.S., Mexico and the E.U.. The first stage\* will consist of two pilot Initiatives

\*One Initiative for 100 families in the U.S.-Mexico and one for 100 families in the E.U. -Arabic re-migration. At a combined estimated \$1,3 million dollars. All funding will be handled in terms of international audit standards and with full disclosure.

***Overall A Second Chance offers major benefits*** for:-

**Undocumented migrants.** The Initiative opens options to rebuild their lives and make them part of humane solutions to correct their past adverse decisions.

Solutions can include with government support housing options specifically designed to assist migrants.

For the **U.S.** and **Mexican businesses** the benefits range from new growth, new exports and include options

to unlock funding for growth and new job creation expansions.

For the **USA, Mexico** and the **E.U.** the Initiative reduces the costs of redressing undocumented migration and supports economic growth. Including thousands of new jobs can be gained to offset NAFTA's job losses.

A Second Chance delivers new humane options and assists to narrow the economic disparity that drives migration for long-term stability and growth.

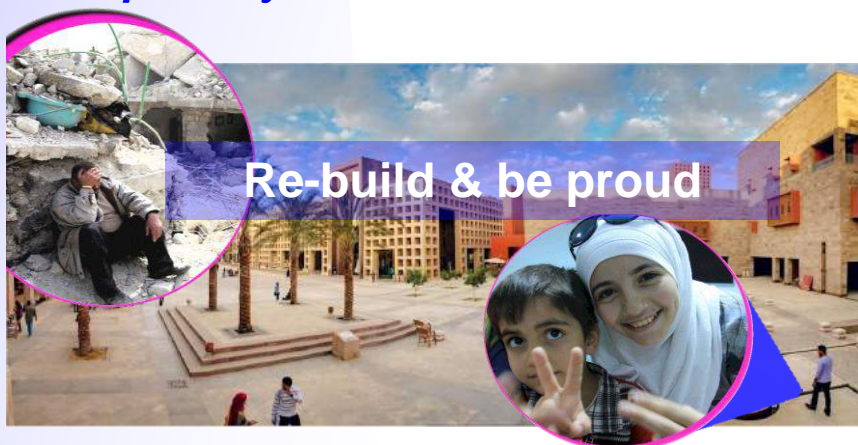
